



Our tennis camp, open to nonmembers, runs for 8 weeks during the summer in a AM-PM format (including lunch), with half-day option. It is made of 3 different levels to fit beginners and advanced players 5 – 18 years old. Some music, snack break, and other games are incorporated during sessions each day. Our renowned staff takes pride in providing the best tennis instruction in the Roanoke Valley and the most fun times of the season for our junior campers.

- **Quickstart (QS):** *youngsters 5-10 years old.* Fun introduction to the game following USTA standards-guidelines. Players are organized according to ability into RED, ORANGE, or GREEN low compression balls to develop basic skills, stroke techniques, body movement, court awareness and score keeping while having a blast. 10:30 – noon (\$120/week or \$25/day).
- **Beginner- Intermediate-Advanced (B/I/A):** 11-17 years old are organized on-court according to abilities & age. It includes developmental instruction-drills and progressive match play. This program promotes some competition, fun, and further development into game play. It aims at improving tennis skills to enable players make their school teams; and being able to enjoy the game for a lifetime. 10:30am – 3:00pm “lunch break: noon-1:30pm” / (\$300/week or \$65/day); *Half-Day Option (AM or PM – no lunch): \$25 members // \$35non-members
- **Jr. High Performance (HP):** This exclusive program aims to develop the more competitive players with advanced levels even further. It involves H.S./USTA tournament players, who wish to excel in junior competition and prepare for possible collegiate play. 10:30am – 3:00pm “lunch break: noon-1:30pm”; (\$300/week or \$65/day). *Half-Day Option (AM or PM – no lunch): \$25 members // \$35non-members
